

REACH Kzoo Waiver of Liability Relating to COVID-19 and Other illnesses

COVID-19 is a contagious virus that is believed to spread mainly through close contact from person-to-person. In response to the health and safety concerns globally, REACH Kzoo has put in place safe, preventative measures to potentially reduce the spread of COVID-19 and other illnesses. However, REACH Kzoo cannot guarantee that you or your children will not become exposed to or infected with any illness.

Out of respect for all of our families, we ask that your child refrain from attending REACH Kzoo if they are experiencing any adverse symptoms such as:

- *Fever (>100 °F) in last 24 hrs
- * Cough
- *Difficulty breathing or shortness of breath
- *Nausea/Vomiting
- *Loss of smell or taste
- *Muscle/body aches

If you or anyone in your family has had close contact with someone who has tested positive or you have tested positive for COVID-19, please refrain from attending REACH Kzoo for 10 days and please notify the REACH Kzoo Board of the situation immediately (email reachkzooboard@gmail.com). While your confidentiality will be strictly maintained, the Board will follow safety protocols and any affected families and tutors will be notified to monitor for COVID-19 symptoms.

Our goal is to keep our REACH Kzoo families as healthy as possible. Certain health measures include, but are not limited to, the wearing of facial coverings as directed by the current state mandates (unless a mask waiver is on file), sanitization of high touch surfaces, following proper handwashing and distancing guidelines. Reminders will be posted throughout the building. Hand sanitizer will be made available throughout the building. Tables, chairs, and doors will be routinely sanitized. If left at home or forgotten, masks will be available at the Welcome Center as needed.
